Introduction

This ForeCAST report analyzes the 41,674 motorcycle thefts for 2018 and recoveries for 2018 and 2019 (through 06/13/19) in the United States (U.S.), and the District of Columbia (D.C.). For the purposes of this report, the information reported to the US Federal Bureau of Investigation's (FBI) National Crime Information Center (NCIC) for motorcycle theft data for 2018 and recovery data for 2018 and 2019 (through 06/13/19) was analyzed by NCIC Make, Model, and Style and Loss Description fields. This report is divided into two sections. The first section analyzes motorcycle thefts in the U.S. for 2018 by: theft year, month, state, city, county, and make. The second section analyzes motorcycle recoveries in the U.S. for 2018 and 2019 (through 06/13/19) by: year, month, state, and make. The appendix at the end of this report includes the methodology of the data editing.

Executive Summary

Overall, there were a total of 41,674 motorcycle thefts in the U.S. in 2018. From 2017 to 2018, motorcycle thefts decreased by 6%. Motorcycle thefts mostly occur in the warmer months; August had the most motorcycle thefts, while February had least thefts. Motorcycle thefts were highest in the state of California (7,035) in 2018. Of the top 10 states, New York had the largest increase (228) in motorcycle thefts and California had the largest decrease (502) in motorcycle thefts from 2017 to 2018. Analysis by city found New York, NY to have the highest count of thefts (1,310) in 2018, with a 34% increase over 2017. There were 2,032 U.S. counties identified in 2018 with a motorcycle theft. The top 25 counties accounted for 32% of motorcycle thefts in 2018, with Los Angeles County ranking 1st at 1,553 thefts. Analysis found Honda to be the manufacturer with the most thefts (8,260) in 2018. Motorcycle manufacturer Zhejiang Riya had the highest percent increase (41%) in motorcycle thefts of the top 15 manufacturers from 2017 – 2018.

Of the 41,674 motorcycle thefts in 2018, 18,534 (44%) were recovered from 01/01/2018 through 06/13/2019. In 2018, August (2,052) and September (1,928) had the largest number of motorcycle recoveries; while January (450) and February (667) had the fewest motorcycle recoveries. From 01/01/2018 through 06/13/2019, California had most (3,467) recoveries statewide. From the top 10 motorcycle recovery states, Colorado had the highest (55%) recovery for 2018 through 06/13/2019. Analysis found Honda to be the manufacturer with the most (3,824) recoveries in 2018 through 06/13/2019. Manufacturer Triumph had the highest rate (64%) of recovery of the top 15 recovered manufacturers in 2018.


SECTION 1: Motorcycle Thefts in the U.S. 2018

This section analyzes the 41,674 motorcycle thefts which were reported to NCIC, in the U.S. in 2018. The following subsections further analyze the 41,674 motorcycle thefts by: theft year, month, state, city, county, and make.



Motorcycle Thefts: By Year

The following graph shows the comparison of reported motorcycle thefts in the U.S. for the theft years of 2015 through 2018. The number of motorcycle thefts increased by 2% from 45,555 in 2015 to 46,467 in 2016. The number of motorcycle thefts decreased by 5% from 46,467 in 2016 to 44,268 in 2017. The number of motorcycle thefts decreased by 6% from 44,268 in 2017 to 41,674 in 2018. Overall, motorcycle thefts decreased by 9% from 2015 through 2018.




Motorcycle Thefts: By Month

The following tables and bar graph illustrate motorcycle thefts in the U.S. by the month, percent, rank, and quarter. In general, motorcycle thefts are a seasonal crime related to warmer months, with 10% or more of thefts from the yearly total occurred in May, June, July, August, September, and October. Months with 6% or less of thefts from the yearly total occurred in cooler months of December, January, February, and March.

Motorcycle Thefts: By State


The following table shows the number of 2018 motorcycle thefts in the U.S. by theft state. The table analyzes each state by quarters as well as ranks each state by total number of motorcycle thefts. The table further shows the percent of total U.S. thefts by state. There was a total of 41,674 thefts in the U.S. in 2018 with the top 10 states of California, Florida, Texas, New York, South Carolina, North Carolina, Indiana, Missouri, Georgia, and Colorado accounting for over 60% of the total U.S. thefts in 2018.




The following graph shows the top 10 states with the largest number of motorcycle thefts in the U.S. for 2018 compared to theft counts for 2017. Four (4) of the top 10 states saw an increase in motorcycle thefts in 2018 and 6 of the top 10 states saw a decrease in motorcycle thefts. Of the top 10 states, New York had the largest increase (228) in motorcycle thefts and California had the largest decrease (502) in motorcycle thefts from 2017 to 2018.

Motorcycle Thefts: By City


The following tables show the top 15 cities in the U.S., listed by 2018 theft count. The top 15 cities accounted for 7,050 motorcycle thefts in 2018, an increase of 209 motorcycle thefts from 6,841 top 15 city motorcycle thefts in 2017. Of the top 15 cities, 9 had an increase in motorcycle thefts in 2018 with the largest increase (250%) for San Jose, CA followed by Jacksonville, FL in 2nd (136%), and New York, NY in 3rd (34%). Six (6) cities listed a decrease in motorcycle thefts in 2018 with San Diego, CA listed as the largest decrease (38%).

Motorcycle Thefts: By County


The following table displays the top 25 counties in 2018 with motorcycle thefts. The top 25 counties accounted for 13,141 thefts or 32% of the 41,674 motorcycle thefts in 2018. Los Angeles County was determined to have the highest count of thefts; 1,553 in 2018. The table lists the top 25 counties, theft counts for 2018, theft counts for 2017, and a percent change between 2017 and 2018. Of the top 25 counties, 12 saw an increase in motorcycle thefts between 2017 and 2018 while 13 saw a decrease. The table also lists each county's rate of motorcycle theft per 10,000 people, based on the estimated 2018 U.S. Census population. Each county in the table divides the 2018 motorcycle theft county count by the U.S. Census population estimate for the county, with a set population parameter at 10,000. The rate is rounded to a whole number value with a higher rate indicating higher prevalence of theft when using the county population to show county rate

The following map illustrates a total list of counties and their theft count for 2018. The U.S. Census Bureau identified 3,142 counties in the U.S. In 2018, motorcycle thefts were identified in 2,032 U.S. counties.





Motorcycle Thefts: By Make

There were a total of 521 motorcycle makes identified within the 41,674 motorcycle thefts in the U.S. in 2018. The following table displays the top 15 makes¹ with motorcycle thefts in 2018. The top 15 makes accounted for 35,095 of the total 41,674 thefts in 2018 or 84%. Honda accounted for the most thefts in 2018 with 8,260, with Yamaha 2nd (6,655), and Kawasaki 3rd (4,882). Five (5) of the top 15 makes had an increase in the reported number of thefts in 2018 compared to 2017. Motorcycle manufacturer Zhejiang Riya had the highest percent increase (41%) in motorcycle thefts of the top 15 manufacturers from 2017 – 2018.




SECTION 2: Motorcycle Recoveries in the U.S. (2018 through 06/13/19)

This section analyzed the 2018 U.S. motorcycle thefts recovered between 01/01/2018 through 06/13/2019. There were 18,534 motorcycle recoveries for 01/01/2018 through 06/13/2019 associated with the 41,674 motorcycle thefts in the U.S. Of the 18,534 motorcycle recoveries, 16,261 recoveries occurred between 01/01/2018 through 12/31/2018 and 2,273 were between 01/01/2019 through 06/13/2019. The following subsections further analyze these 18,534 recoveries by: year, month, state, and motorcycle make.

Motorcycle Recoveries: By Year

The pie chart shows the recoveries, which was 44% for the 2018 motorcycle thefts recovered in 2018 through 06/13/2019. Analyzing the recoveries by year for 2017 and 2018, the table shows there was a decrease in recoveries from a total of 17,366 motorcycles recovered in the year 2017 compared to 16,261 in 2018.

Motorcycle Recoveries: By Month


The following chart shows the number of motorcycle recoveries by month from 2018 through 06/13/19 for 2018 motorcycle thefts. The chart is analyzed by months and years. The highest recovery occurred in August with 2,052 recoveries followed by September with 1,928 recoveries. The months with the fewest number of motorcycle recoveries in 2018 were January (450) and February (667).

Motorcycle Recoveries: By State

The graph below shows the top 10 sates for motorcycles stolen in 2018 and recovered between 2018 through 06/13/2019. The top 10 states accounted for 10,549 motorcycle recoveries, or 57% between 2018 through 06/13/2019. The state with the most motorcycle recoveries was California with 3,467 or 19% of the 18,534 motorcycle recoveries between 01/01/2018 and 06/13/2019.





Motorcycle Recoveries: By Make

A total of 338 motorcycle makes were identified from the 18,534 motorcycle recoveries in the U.S. from 2018 through 06/13/2019. The following table and graph display the top 15 makes³ of motorcycle recoveries. The top 15 makes accounted for 15,637 or 84% of the 18,534 motorcycle recoveries. The make with the most recoveries was Honda which accounted for 21% of the total motorcycle recoveries. Of the top 15 makes, Triumph had the highest rate of recovery at 64%.

Appendix A: Motorcycle Theft

The NCIC theft data from 2018 was edited in the following manner:

- Records with thefts of anything other than motorcycle models were removed.
- Records with blank or incomplete VIN fields were removed.
- Records with motorcycle parts (wheels, tracks, etc.) were removed.
- ATVs, UTV, watercraft, golf carts, motorized wheelchairs, snowmobiles, toys, go-carts, farm equipment, etc. that were mislabeled as a motorcycle style were removed.
- VIN structures that began with "ATV" were removed.
- VMA was used to identify Manufacturers.
- VMO was used to identify Cycles.
- Records determined to be purged were removed.
