Introduction

This ForeCAST report analyzes the 40,830 motorcycle thefts for 2019 and recoveries for 2019 and 2020 (through 07/13/20) in the United States (U.S.), and the District of Columbia (D.C.). For the purposes of this report, the information reported to the US Federal Bureau of Investigation's (FBI) National Crime Information Center (NCIC) for motorcycle theft data for 2019 and recovery data for 2019 and 2020 (through 07/13/20) was analyzed by NCIC Make, Model, and Style and Loss Description fields. Motorcycles have different legal definitions depending on jurisdiction. There are many sub-types of motorcycles, and this report includes scooters and mopeds and others classified as motorcycles in the NCIC data. This report is divided into two sections. The first section analyzes motorcycle thefts in the U.S. for 2019 by: theft year, month, state, city, county, and make. The second section analyzes motorcycle recoveries in the U.S. for 2019 and 2020 (through 07/13/20) by: year, month, state, and make. The appendix at the end of this report includes the methodology of the data editing.

Executive Summary

This section analyzes the 40,830 motorcycle thefts which were reported to NCIC, in the U.S. in 2019. The following subsections further analyze the 40,830 motorcycle thefts by: theft year, month, state, city, county, and make. From 2018 to 2019, motorcycle thefts decreased by 2%. Motorcycle thefts mostly occur in the warmer months; August had the most motorcycle thefts, while February had least thefts. Motorcycle thefts were highest in the state of California (6,913) in 2019. Of the top 10 states, Missouri had the largest increase (155) in motorcycle thefts and New York had the largest decrease (204) in motorcycle thefts from 2018 to 2019. Analysis by city found New York, NY to have the highest count of thefts (1,195) in 2019, with a 9% decrease over 2018.

There were 2,002 U.S. counties identified in 2019 with a motorcycle theft. The top 25 counties accounted for 32% of motorcycle thefts in 2019, with Los Angeles County ranking 1st at 1,423 thefts. Analysis found Honda to be the manufacturer with the most thefts (8,122) in 2019. Motorcycle manufacturer Yongfu Machine Co. had the highest percent increase (116%) in motorcycle thefts of the top 15 manufacturers from 2018 – 2019.

Of the 40,830 motorcycle thefts in 2019, 18,857 (46%) were recovered from 01/01/2019 through 07/13/2020. In 2019, August (2,092) and September (2,065) had the largest number of motorcycle recoveries; while January (469) and February (540) had the fewest motorcycle recoveries. From 01/01/2019 through 07/13/2020, California had most (3,529) recoveries statewide.

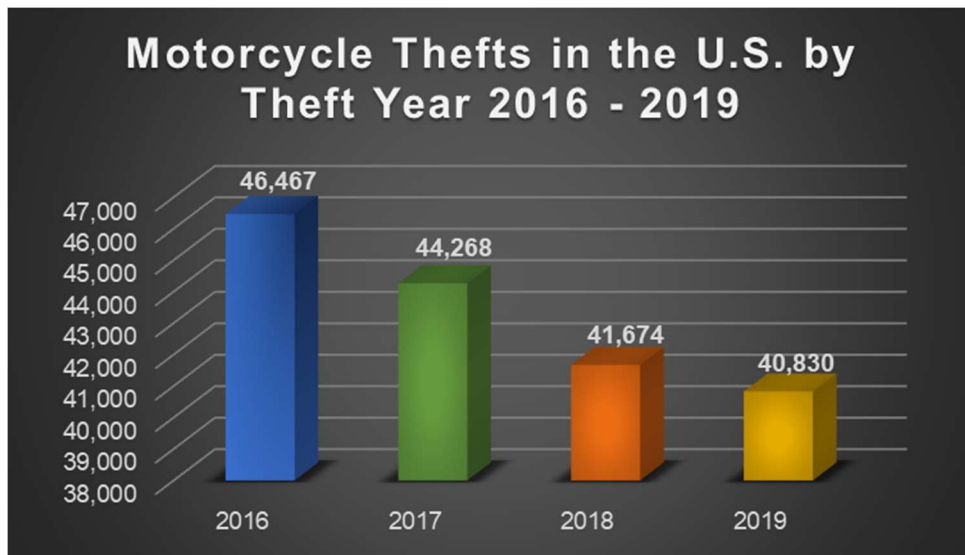
From the top 10 motorcycle recovery states, Washington had the highest (52%) recovery for 2019 through 07/13/2020. Analysis found Honda to be the manufacturer with the most (3,870) recoveries in 2019 through 07/13/2020. Manufacturer Genuine Cycle had the highest rate (66%) of recovery of the top 15 recovered manufacturers in 2019.

SECTION 1: Motorcycle Thefts in the U.S. 2019

This section analyzes the 40,830 motorcycle thefts which were reported to NCIC, in the U.S. in 2019. The following subsections further analyze the 40,830 motorcycle thefts by: they year, month, state, city, county, and make.

Motorcycle Thefts: By Year

The following graph shows the comparison of reported motorcycle thefts in the U.S. for the theft years of 2016 through 2019. The number of motorcycle thefts decreased by 5% from 46,467 in 2016 to 44,268 in 2017. The number of motorcycle thefts decreased by 6% from 44,268 in 2017 to 41,674 in 2018. The number of motorcycle thefts decreased by 2% from 41,674 in 2018 to 40,830 in 2019. Overall, motorcycle thefts decreased by 12% from 2016 through 2019.

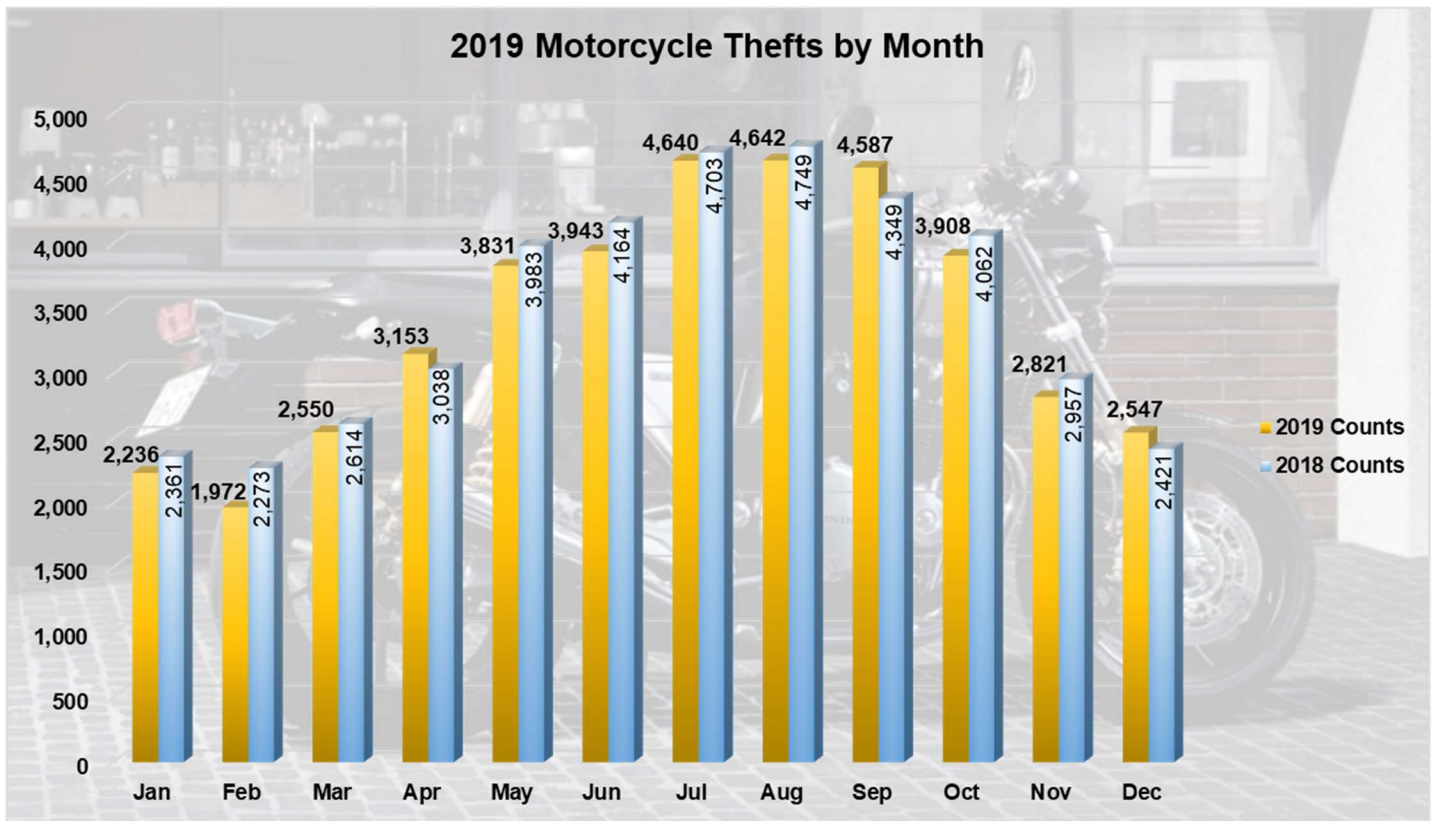


Motorcycle Thefts: By Month

The following tables and bar graph illustrate motorcycle thefts in the U.S. by the month, percent, rank, and quarter. In general, motorcycle thefts are a seasonal crime related to warmer months, with 11% or more of thefts from the yearly total occurred in August, July, and September. Months with 5% or less of thefts from the yearly total occurred in cooler months of January, and February.

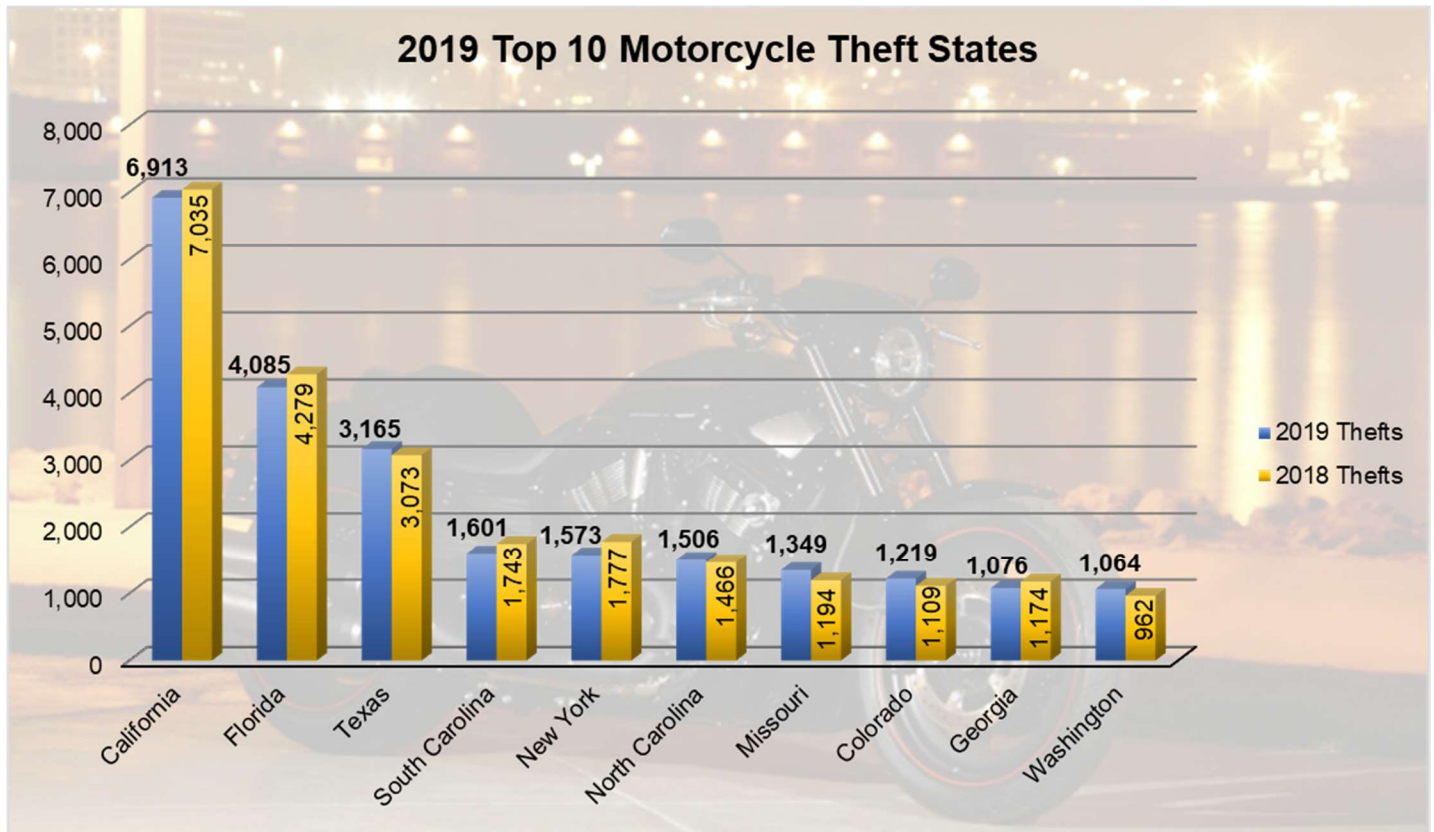
Motorcycle Thefts: By State

The following table shows the number of 2019 motorcycle thefts in the U.S. by theft state. The table analyzes each state by quarters as well as ranks each state by total number of motorcycle thefts. The table further shows the percent of total U.S. thefts by state. There was a total of 40,830 thefts in the U.S. in 2019 with the

top 10 states of California, Florida, Texas, South Carolina, New York, North Carolina, Missouri, Colorado, Georgia, and Washington accounting for over 58% of the total U.S. thefts in 2019.

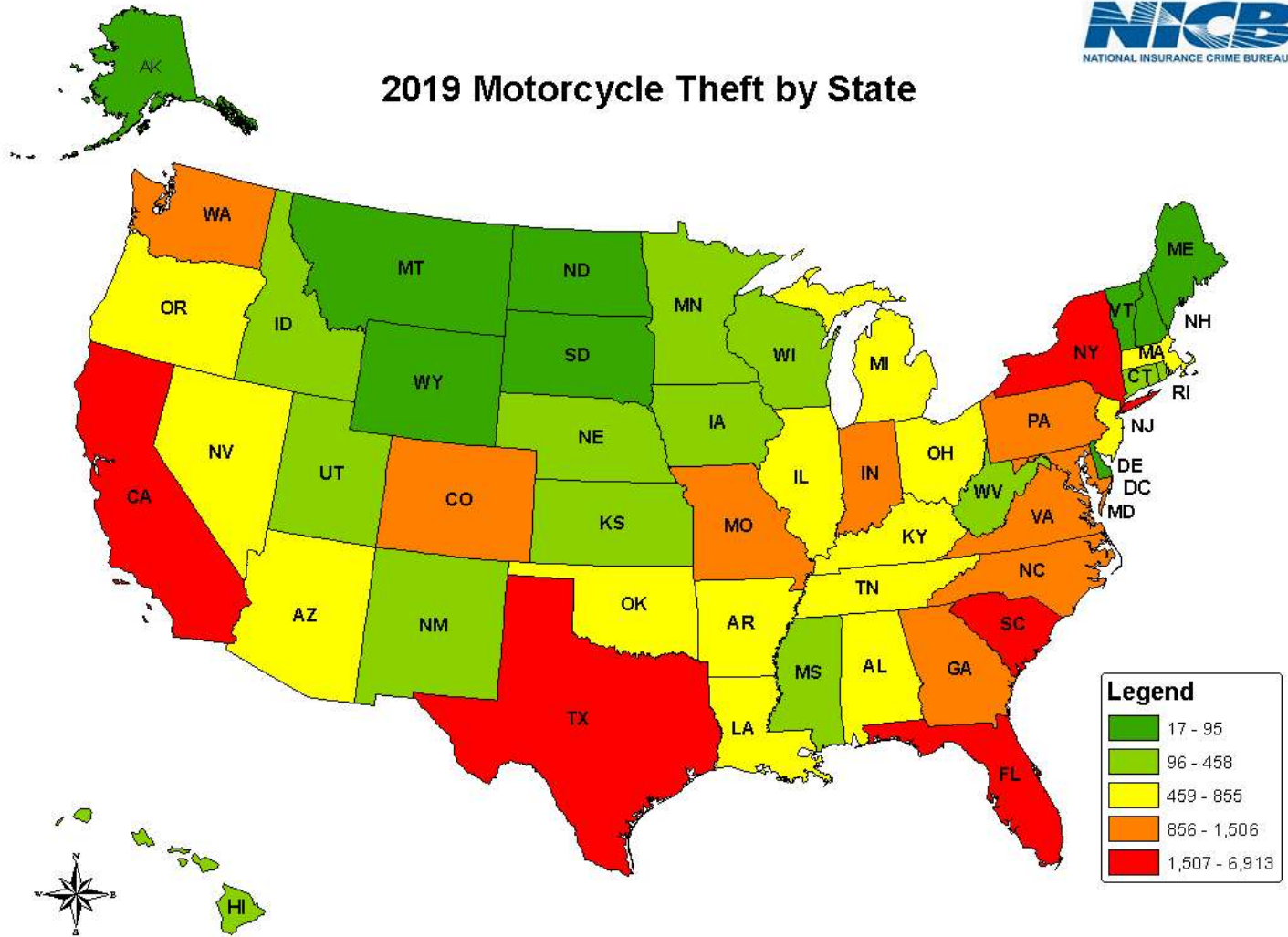

The following graph shows the top 10 states with the largest number of motorcycle thefts in the U.S. for 2019 compared to theft counts for 2018. Five (5) of the top 10 states saw an increase in motorcycle thefts in 2019 and 5 of the top 10 states saw a decrease in motorcycle thefts. Of the top 10 states, Missouri had the largest increase (155) in motorcycle thefts and New York had the largest decrease (204) in motorcycle thefts from 2018 to 2019.

2019 Motorcycle Theft by State



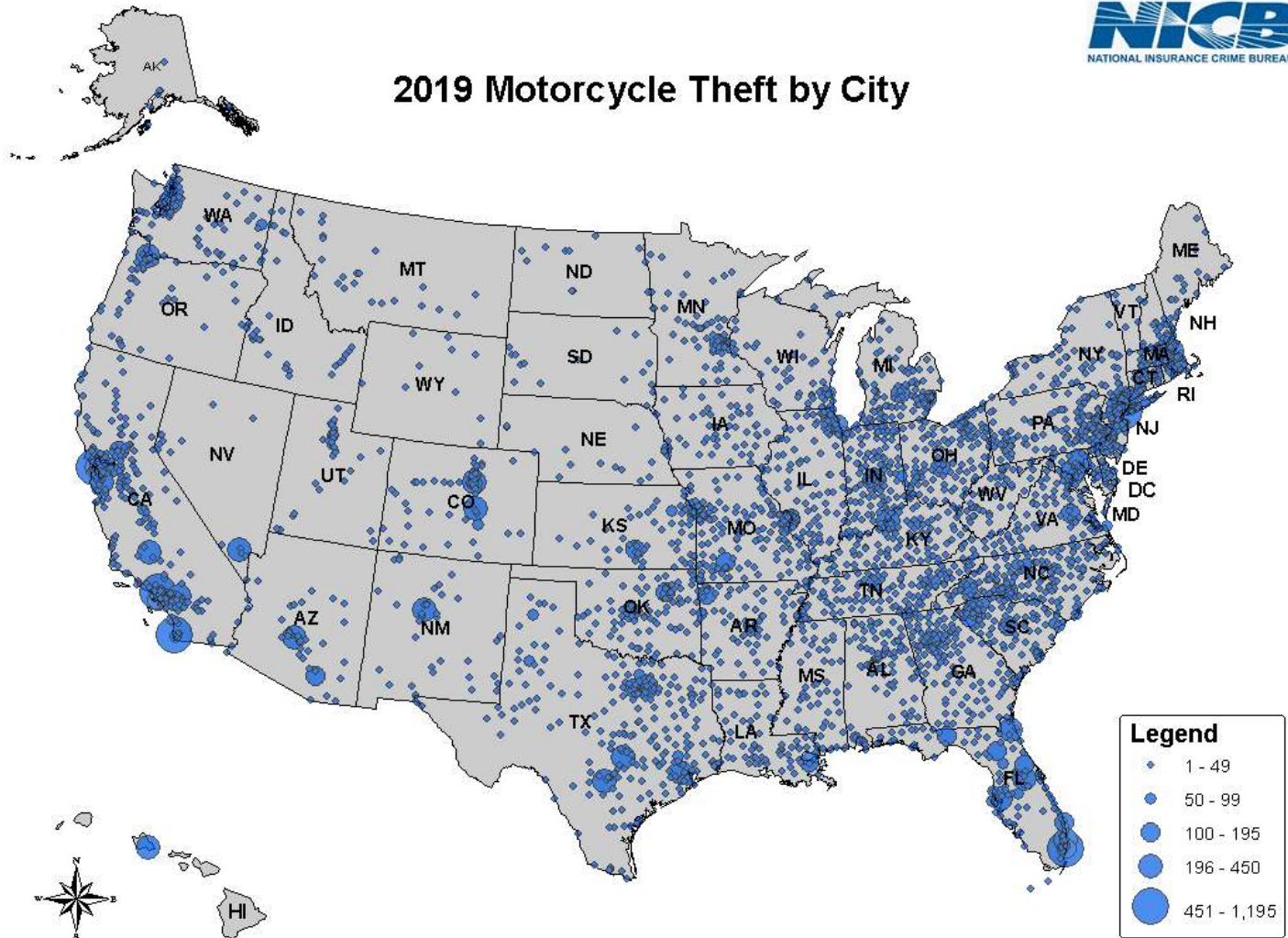
Motorcycle Thefts: By City

The following tables show the top 15 cities in the U.S., listed by 2019 theft count. The top 15 cities accounted for 7,178 motorcycle thefts in 2019, an increase of 128 motorcycle thefts from 7,050 top 15 city motorcycle thefts in 2018. Of the top 15 cities, 8 had an increase in motorcycle thefts in 2019 with the largest increase (50%) for Seattle, WA followed by San Diego, CA in 2nd (46%), and Baltimore, MD in 3rd (36%). Seven (7) cities listed a decrease in motorcycle thefts in 2019 with Philadelphia, PA listed as the largest decrease (21%).

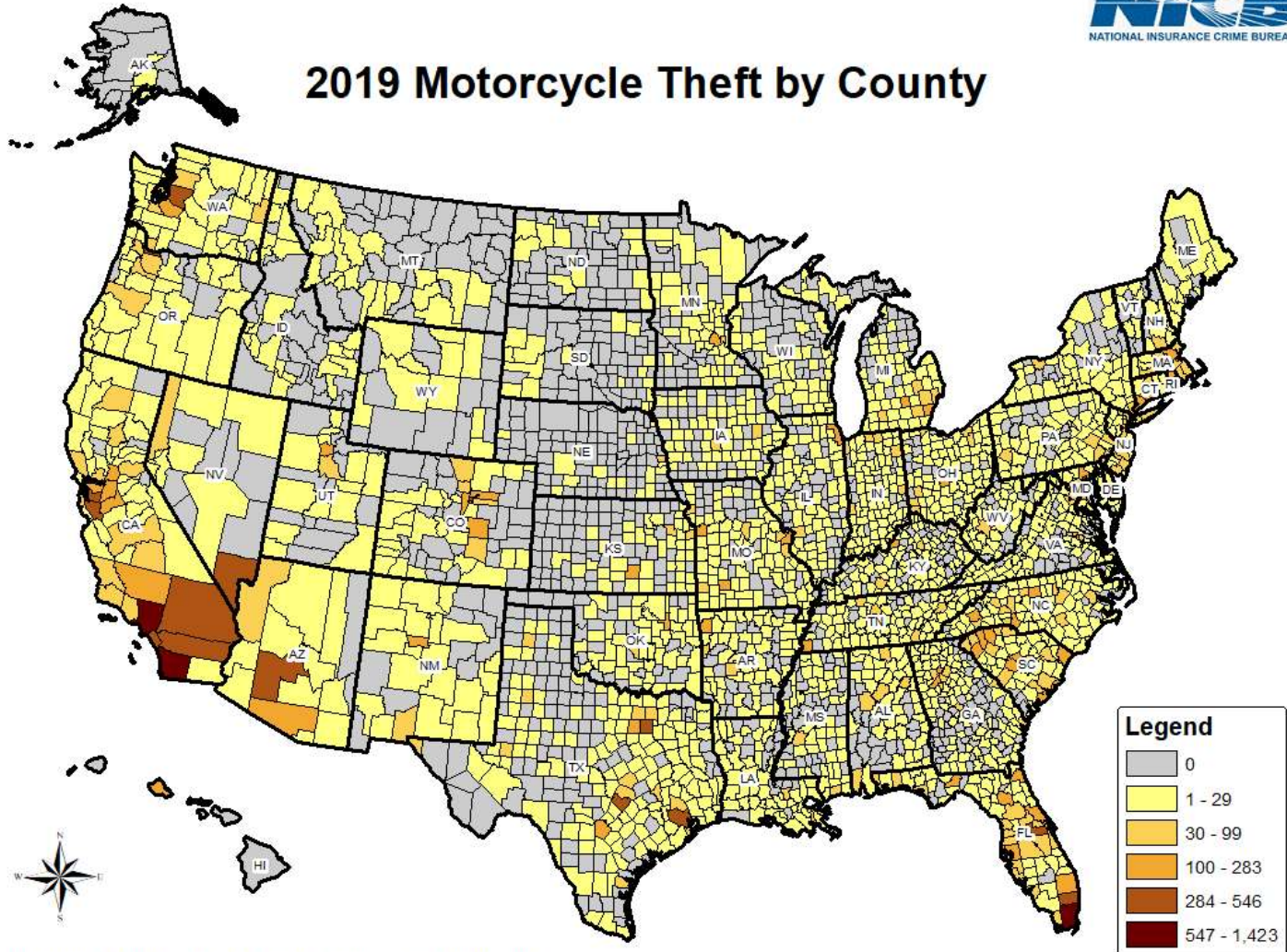
Motorcycle Thefts: By County

The following table displays the top 25 counties in 2019 with motorcycle thefts. The top 25 counties accounted for 12,898 thefts or 32% of the 40,830 motorcycle thefts in 2019. Los Angeles County was determined to have the highest count of thefts; 1,423 in 2019. The table lists the top 25 counties, theft counts for 2019, theft counts for 2018, and a percent change between 2018 and 2019. Of the top 25 counties, 12 saw an increase in motorcycle thefts between 2018 and 2019 while 13 saw a decrease. The table also lists each county's rate of motorcycle theft per 10,000 people, based on the estimated 2019 U.S. Census population. Each county in the table divides the 2019 motorcycle theft county count by the U.S. Census population estimate for the county, with a set population parameter at 10,000. The rate is rounded to a whole number value with a higher rate indicating higher prevalence of theft when using the county population to show county rate.

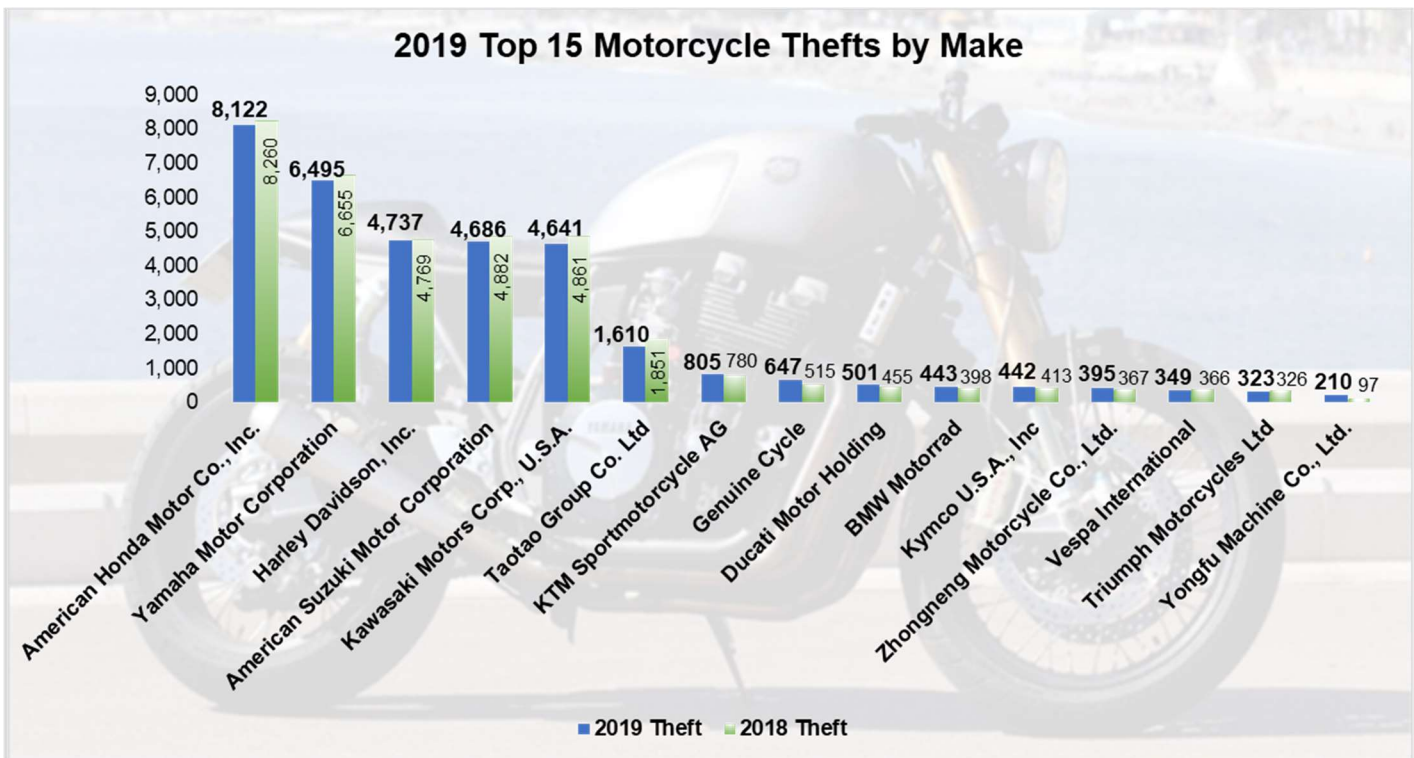
Motorcycle Thefts: By Make

There were a total of 478 motorcycle makes identified within the 40,830 motorcycle thefts in the U.S. in 2019. The following table displays the top 15 makes¹ with motorcycle thefts in 2019. The top 15 makes accounted for 34,406 of the total 40,830 thefts in 2019 or 84%. Honda accounted for the most thefts in 2019 with 8,122, with Yamaha 2nd (6,495), and Harley Davidson 3rd (4,737). Seven (7) of the top 15 makes had an increase in the reported number of thefts in 2019 compared to 2018. Motorcycle manufacturer Yongfu Machine Co.² had the highest percent increase (116%) in motorcycle thefts of the top 15 manufacturers from 2018 – 2019.

¹ 1,478 (CYCL) motorcycle records were not included in the top 15 motorcycle theft makes as the manufacturer was not specifically identified.

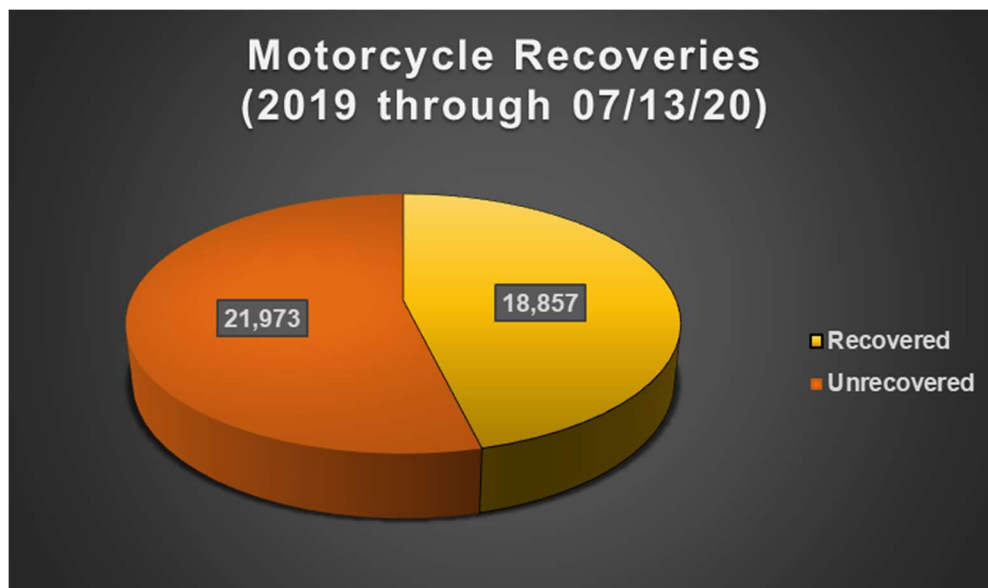


SECTION 2: Motorcycle Recoveries in the U.S. (2019 through 07/13/20)

This section analyzed the 2019 U.S. motorcycle thefts recovered between 01/01/2019 through 07/13/2020. There were 18,857 motorcycle recoveries for 01/01/2019 through 07/13/2020 associated with the 40,830 motorcycle thefts in the U.S. Of the 18,857 motorcycle recoveries, 16,397 recoveries occurred between 01/01/2019 through 12/31/2019 and 2,460 were between 01/01/2020 through 07/13/2020. The following subsections further analyze these 18,857 recoveries by: year, month, state, and motorcycle make.

Motorcycle Recoveries: By Year

The pie chart shows the recoveries, which was 46% for the 2019 motorcycle thefts recovered in 2019 through 07/13/2020. Analyzing the recoveries by year for 2018 and 2019, the table shows there was an increase in recoveries from a total of 16,261 motorcycles recovered in the year 2018 compared to 16,397 in 2019.

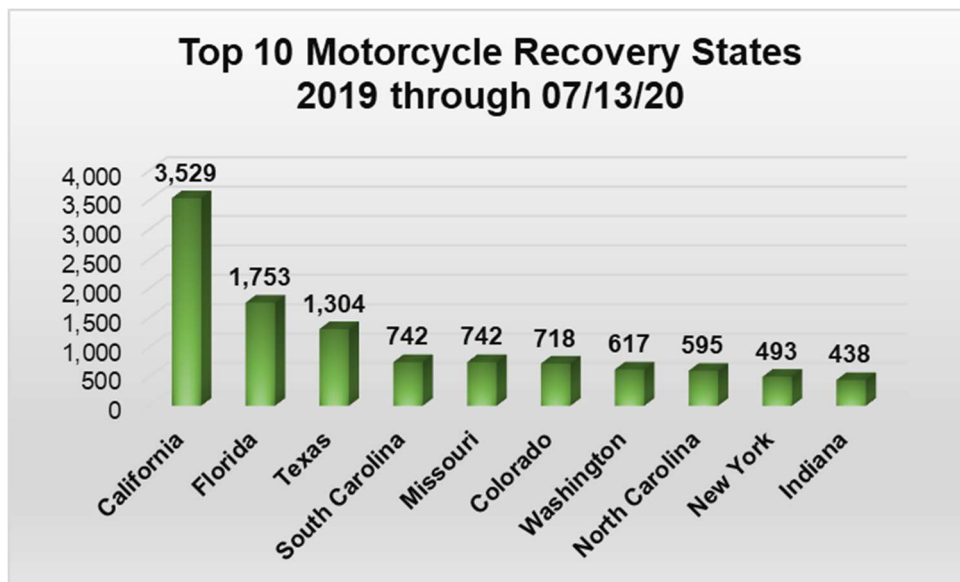
Motorcycle Recoveries: By Month

The following chart shows the number of motorcycle recoveries by month from 2019 through 07/13/20 for 2019 motorcycle thefts. The chart is analyzed by months and years. The highest recovery occurred in August with 2,092 recoveries followed by September with 2,065 recoveries in 2019. The months with the fewest number of motorcycle recoveries in 2019 were January (469) and February (540).

Motorcycle Recoveries: By State

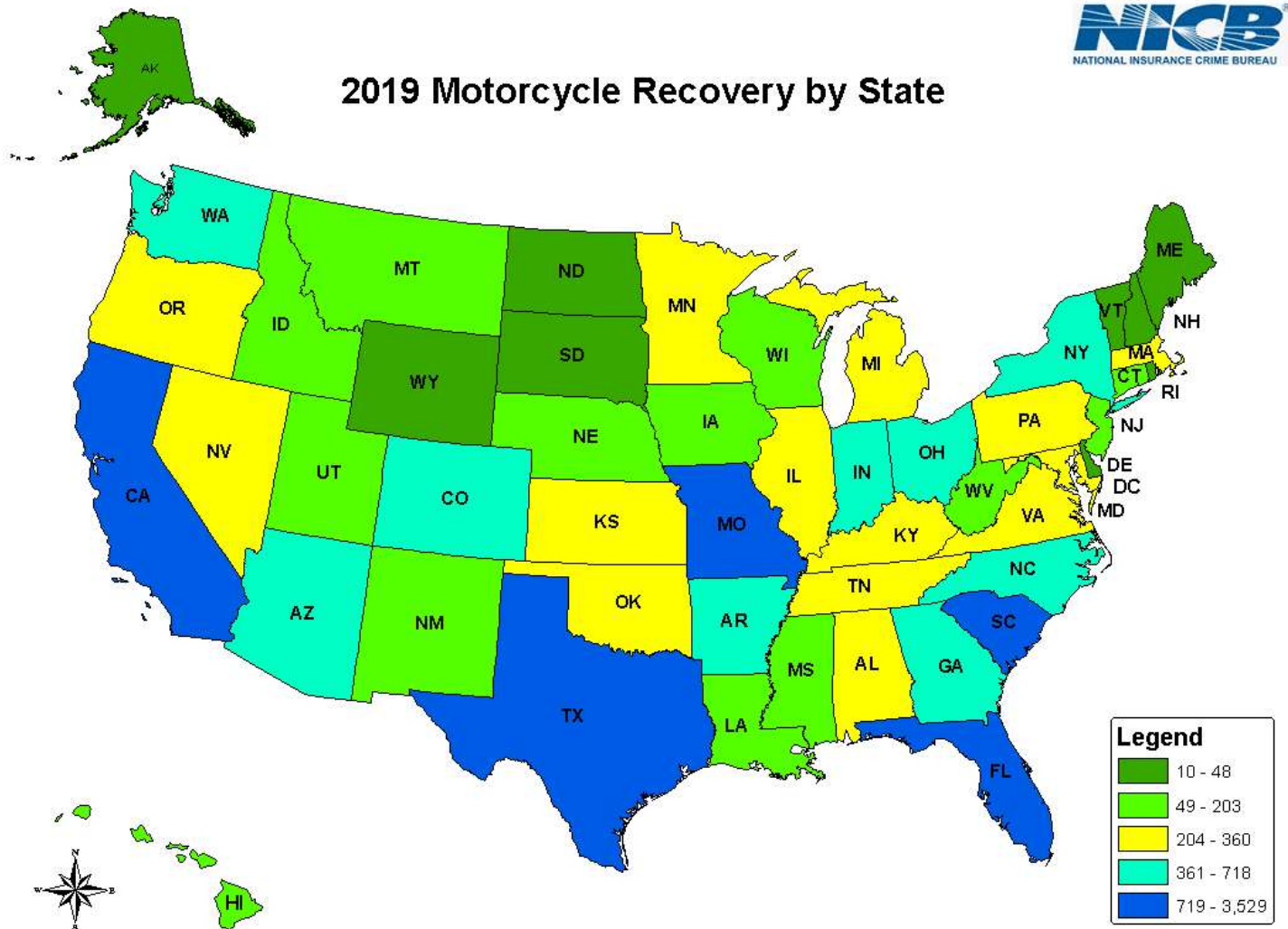
The graph below shows the top 10 states for motorcycles stolen in 2019 and recovered between 2019 through 07/13/2020. The top 10 states accounted for 10,931 motorcycle recoveries, or 58% between 2019 through 07/13/2020. The state with the most motorcycle recoveries was California with 3,529 or 19% of the 18,857 motorcycle recoveries between 01/01/2019 and 07/13/2020.

Motorcycle Recoveries: By Make

A total of 329 motorcycle makes were identified from the 18,857 motorcycle recoveries in the U.S. from 2019 through 07/13/2020. The following table and graph display the top 15 makes⁴ of motorcycle recoveries. The top 15 makes accounted for 15,907 or 84% of the 18,857 motorcycle recoveries. The make with the most recoveries was Honda which accounted for 21% of the total motorcycle recoveries. Of the top 15 makes, Genuine Cycle had the highest rate of recovery at 66%.

Appendix A: Motorcycle Theft

The NCIC theft data from 2019 was edited in the following manner:

- Records with thefts of anything other than motorcycle models were removed.
- Motorcycle has different legal definitions depending on jurisdiction.
- Sub-types of mopeds, trikes, and scooters are included in motorcycle.
- Records with blank or incomplete VIN fields were removed.
- Records with motorcycle parts (wheels, tracks, etc.) were removed.
- ATVs, UTV, watercraft, golf carts, motorized wheelchairs, snowmobiles, toys, go-carts, farm equipment, etc. that were mislabeled as a motorcycle style were removed.
- VIN structures that began with "ATV" were removed.
- VMA was used to identify Manufacturers.
- VMO was used to identify Cycles.
- Records determined to be purged were removed.
